**Janusz Bugajski** is the director of the Eastern Europe Project at the Center for Strategic and International Studies in Washington, D.C. Bugajski runs the South-Central Europe area studies program at the Foreign Service Institute (FSI), U.S. Department of State. He has served as a consultant for the U.S. Department of Defense, the U.S. Agency for International Development (USAID), the International Research and Exchanges Board (IREX), the International Republican Institute (IRI), and several private organizations and foundations. He has testified before various congressional committees and in 1998 was the recipient of the Distinguished Public Service. His books include *Political Parties of Eastern Europe: A Guide to Politics in the Post-Communist Era*; *Ethnic Politics in Eastern Europe: A Guide to Nationality Policies, Organizations, and Parties*; *Nations in Turmoil: Conflict and Cooperation in Eastern Europe*; *East European Fault Lines: Dissent, Opposition, and Social Activism*; and *Czechoslovakia: Charter 77's Decade of Dissent*. He is a regular contributor to various U.S. newspapers, publishes in international journals, and is a columnist for several East European newspapers, including *Nacional* in Croatia, *Koha Ditore* in Kosovo, *Albania* in Albania, and *Kapital* in Bulgaria.

**László Csaba** graduated from the Budapest University of Economics (BUES) in 1976 and received his Ph.D. in 1984. From 1976 to 1987, Dr. Csaba was associated with the Institute for World Economy and from 1998 to 2000 with the Kopint-Datorg Economic Research Center, both in Budapest. Between 1991 and 1997, he was honorary professor of international economics at the College of Foreign Trade in Budapest, and was named full

professor of comparative economics. Dr. Csaba has been a visiting professor at various universities, including Bocconi University, Milan; University of Helsinki; Europa Universitat Viadrina, Frankfurt; and the Free University of Berlin. Dr. Csaba also serves on the editorial board of several scholarly journals, including *Intereconomics* (Germany), *Europe-Asia Studies* (United Kingdom), *Voprosy Ekonomiki* (Russia), *Russian and East European Finance and Trade* (United States), and *Acta Oeconomica*, *Közgazdasági Szemle*, and *Külgazdaság* (Hungary). He has written 170 articles and chapters in books published in 18 countries, and he is also the author and editor of ten books, including *Eastern Europe in the World Economy* and *Small Economies' Adjustment to Global Challenges*.

**Aleksander Duleba** is director of the Research Center of the Slovak Foreign Policy Association (SFPA). A graduate of Comenius University in the Slovak Republic, Dr. Duleba received a Ph.D. in political science from the Slovak Academy of Sciences, Bratislava, in 1998. Throughout his career, he has published a variety of books and articles, which include forty-four completed field studies on Eastern Europe. His latest books include *Russia at the End of Yeltsin's Era: Foreign and Domestic Politics, NATO Enlargement, and Slovakia's Interests*; *Ukraine and Slovakia: Geopolitical Characteristics of State-Building*; and *International Position of Ukraine: Implications for Slovakia*. In addition, Dr. Duleba has contributed to several books, including *The EU Accession States and Their Eastern Neighbors* and *On the Edge: Ukrainian–Central European–Russian Security Triangle*.

**Marko Mihkelson** is director of the Baltic Center for Russian Studies, where he monitors current political, economic, and military developments in Russia, with the goal of improving overall understanding of Russia's impact on the Baltic region. He graduated from the University of Tartu in Estonia where his thesis was entitled "Russian Political Development in 1990–96." Mr. Mihkelson worked for an eminent Estonian daily newspaper, *Postimees*, from 1994 to 1997 as its Moscow correspondent, and from 1997–2000 as its editor-in-chief. He has also published columns and analyses on Russia in various international outlets, including *Economic Trends* (Finland), *Radio Free Europe*, *Postimees*, *Internatum* (University of Helsinki), and the *Baltic Times*.

**Hryhoriy Nemyria** is director of the Center for European and International Studies (CEIS) at the Institute of International Relations of Taras Shevchenko University in Kyiv. He is also chairman of the Department for European Integration at the Ukrainian Academy of Public Administration; chairman of the board, Ukrainian International Studies Association; and editor, *New Security: Ukrainian Journal on World Affairs*. He is an expert on European integration, regionalism, and Ukrainian foreign policy. In

1992 he founded the Center for Political Studies, a policy institute in Donetsk, Ukraine. In 1996–98, Dr. Nemyria was Dean of the Graduate School at the National University of Kyiv Mohyla Academy. In 1994 he was a National Forum Foundation Fellow at the Center for Strategic and International Studies (CSIS), Washington, D.C. Since that time he has been a CSIS Adjunct Fellow. Dr. Nemyria is the Chairman of the International Renaissance (Soros) Foundation in Ukraine and a member of Freedom House's Central and Eastern Europe Advisory Committee.

**Katarzyna Pełczyńska-Nałęcz** is head of the Russian Department at the Center for Eastern Studies (CES) and assistant professor at the Institute of Philosophy and Sociology at the Polish Academy of Science in Warsaw. Dr. Pełczyńska-Nałęcz graduated from the Sociology Department of Warsaw University in 1994. She received her Ph.D. in 1999 at the Institute of Philosophy and Sociology, Polish Academy of Science. Her thesis was entitled "Dynamics of Political Participation under Systemic Transformation: Poland 1989–99." Her research work focuses on two topics: the analysis of the social and political situation in the Russian Federation and analysis of political transformation in Poland and the other central European countries. Her publications include "Oil and Natural Gas in the Russian Federation"; "Center-Regions: The Division of Incomes in the Russian Federation"; "The Dynamics of Systemic Preferences of Poles 1990–95"; "Political Participation under Systemic Transformation"; "The Russian Federation: The Return of the State"; "The Russian Federation—Characteristics of the Political System"; and "The Kaliningrad Oblast in the Context of EU Enlargement."

**Marcin A. Piotrowski** is a member of the editorial board of *Strategic Yearbook* published by the University of Warsaw. He holds an M.A. in International Relations (thesis entitled "Commonwealth of Independent States 1991–98") and an M.A. in Political and Social Sciences from the University of Warsaw. He has also been a student in the Postgraduate National Security Faculty in Warsaw. Currently he is working on his Ph.D. thesis at the Institute of Foreign Relations at the University of Warsaw on the problems of Caspian regional security. He has conducted field research in Iran and several Central Asian countries. He has published analytical articles about Ukraine, Russia, and other CIS countries in *Strategic Yearbook*. He also contributed the chapter "Poland: Returning to Europe" in *Enlarging NATO: The National Debates*, and to the *Yearbook of Polish Foreign Policy*.

**Leonid Polyakov** is director of Military Programs at the Ukrainian Center for Economic and Political Studies (UCEPS) in Kyiv. Previously he served as state expert at the National Security and Defense Council Staff, Ukraine. His previous assignments included a combat tour as company command-

er in Afghanistan, two years of military service in Russia's Kaliningrad *oblast*, three years of military service in the Russian Far East, and group chief (U.S./Ukraine military contacts) and senior research fellow in the General Staff of Ukraine's armed forces. He is a graduate of the U.S. Army War College and Frunze Military Academy (Moscow). He guided the development of UCEPS 2000 analytical reports, including "Military Reform in Ukraine: START, or Another False Start?" "Democratic Civilian Control over the Military in Ukraine: On the Path From Form to Substance," "Ukraine's Relations with NATO within the Context of European Security," and "Development of an Export Control System in Ukraine in the Context of Regional Security." His numerous publications cover a broad range of Ukrainian and regional security issues.

**László Póti** is senior researcher at the Strategic and Defense Research Institute in Budapest. His field of research includes post-Soviet foreign policy, post-Soviet–East European relations, and Hungarian foreign policy. Dr. Póti graduated from the Moscow State Institute of International Relations in 1984 and received his Ph.D. in International Relations at the Budapest University of Economic Science in 2000. He was also a research fellow at the Hungarian Institute of International Affairs from 1987 to 1997. His publications include *Les aspirations et dilemmes de la politique extérieure hongroise face à la crise yougoslave*; *Relations with the Former Socialist Countries*, (ed. Bela K. Kiraly); *Lawful Revolution in Hungary, 1989–95*; *The Land of Doctrines: Russia's Policy in the Post-Soviet Region and in East Central Europe*; and *From Subordination to Partnership: Hungarian–Russian Relations, 1990–1997*.

**Krzysztof Strachota** is director of the Central Asia and Caucasus Section at the Center for Eastern Studies (CES) in Warsaw. He specializes in security problems of the Caspian region (including Central Asia and the Caucasus), Afghanistan, Iran, and contemporary Islam in the post-Soviet area. He graduated from the Department of Ethnology and Cultural Anthropology at Warsaw University in Poland. His studies included the cultural aspects of war in the former Yugoslavia and problems of exporting Islamic revolution in Iran (with field research in Qur'anic schools, Qom, Iran). He is also affiliated with the Stefan Batory Foundation (Warsaw) and the Institute for Democracy in Eastern Europe (Washington, D.C.). His recent publications include *Islamic Fundamentalism in Central Asia*; *Uzbekistan in the Regional Political and Security System*; and *New Regional In-security System in Central Asia*.

**Jurgis Vilemas** is director of the Lithuanian Energy Institute (LEI), a position he has held since 1981. He graduated from the Moscow Energy Institute in 1962 and completed his Ph.D. thesis on thermonuclear energy

in 1966. Dr. Vilemas is also a member of the Lithuanian Academy of Sciences, member of the European Atomic Energy Society, chairman of the Lithuanian Association of Energy Economics, member of the Senate of the Kaunas University of Technology, chairman of the Board of Lietuvos Energija, chairman of the National Nuclear Safety Consulting Committee, foreign member of the Royal Swedish Academy of Engineering Sciences, and executive committee member of the International Energy Agency (IEA) Hydrogen Program. Dr. Vilemas was also a member of the Strategy Committee for Energy Strategy of the Soviet Union in the Academy of Sciences from 1986 to 1990, and rector of Vytautas Magnus University. Between 1991 and 2000, he served as an adviser to the Lithuanian government on energy policy.

**Vladimir Votapek** is a Czech political scientist and diplomat. He has also been principal researcher on Russia at the Czech Institute for International Relations since 2001. Mr. Votapek graduated from the Czech Technical University (Prague) and studied at Moscow State University, Oslo University, Charles University (Prague), and the Clingendael Institute (The Hague). During 1986–90, he taught social sciences at the Czech Technical University. In 1992, he joined the Czech Foreign Ministry. During the 1990s, he served as secretary at the Czech Embassy in Moscow and as consul general in St. Petersburg, Russia. His publications include *Russian Presidential Elections*; *Phases of Russian Foreign Policy*; *Russian Crisis*; and *Russia and Religion*.
