ALEJANDRO COLÁS is Senior Lecturer in International Relations in the Politics Department, Birkbeck College, University of London where he directs the Masters Programme in International Security and Global Governance. He is author of *Empire* (2007) and *International civil society: social movements in world politics* (2002) as well as co-editor with Richard Saull of *The war on terror and American 'empire' after the Cold War* (2005) and *Mercenaries, pirates bandits, and empires: private violence in historical context* (2011) with Bryan Mabee. He has also published articles in various International Relations journals.

MICHAEL COX holds a Chair in International Relations at the London School of Economics and Political Science, where he is also co-Director of IDEAS, a centre for the study of strategy and diplomacy. An Associate Fellow of Chatham House, he is currently a member of its North American Advisory Board. He is the author and editor of over 20 books. His latest books include: *Soft power and US foreign policy: theoretical, historical and contemporary perspectives* (co-edited with Inderjeet Parmar, 2010) and *The global 1989: continuity and change in world politics* (co-edited with Chris Armbruster and George Lawson, 2010).

TOBY DODGE is a Reader in International Relations in the Department of International Relations at the London School of Economics and Political Science. From 2006 until 2011 he was a Reader in International Politics at the School of Politics and International Relations, Queen Mary, University of London. His publications include *Iraq's future: the aftermath of regime change* (2005) and *Inventing Iraq: the failure of nation building and a history denied* (2003). His next book, *The future of Iraq beyond civil war and counter-insurgency* will be published in November 2011.

GEORGE LAWSON is Lecturer in International Relations at the London School of Economics and Political Science, having previously worked as a Researcher for the London-based think-tank, Demos. He is the author of *Negotiated revolutions* (2005) and *Anatomies of revolution* (forthcoming), as well as articles in a number of journals, including the *European Journal of International Relations*, *Review of International Studies* and *Political Studies*. His most recent book is *The global 1989: continuity and change in world politics* (co-edited with Chris Armbruster and Michael Cox, 2010).

ANDREW LINKLATER is Woodrow Wilson Professor of International Politics at Aberystwyth University. Over the last few years, he has explored connections between critical theory, English School analysis and process sociology. His most recent book is *The problem of harm in world politics: theoretical investigations* (2011). He is currently working on a second volume on harm provisionally entitled *Violence and civilization in the western states-systems*.

NICHOLAS RENGGER is Professor of Political Theory and International Relations at the University of St Andrews. He has served on the Governing Council of Chatham House from 1997 to 2001, as President of the International Ethics Section of the International Studies Association from 2000 to 2001 and for seven years on the Executive of the British International Studies Association, between 2003 and 2010, whose journal, the *Review of International Studies*, he edited between 2006 and 2010. He is currently a Carnegie Council Global Ethics Fellow in New York. He has published on many aspects of political philosophy, International Relations, intellectual history and theology. His latest books are, *State of war? Teleocratic politics, the just war and the uncivil condition in world politics* (forthcoming) and a volume of essays called *Dealing in darkness: sceptical essays in political theory and International Relations* (forthcoming).

CHRISTIAN REUS-SMIT holds the Chair in International Relations at the European University Institute in Florence. He was Head of the Department of International Relations at the Australian National University from 2001 to 2010 and is a Fellow of the Academy of the Social Sciences in Australia. He is author of *American power and world order* (2004), and *The moral purpose of the state* (1999); co-author of *Special responsibilities: global problems and American power* (forthcoming); editor of *The politics of international law* (2004); and co-editor (with Ian Clark) of 'Resolving international crises of legitimacy' (*International Politics*, 2007) and *The Oxford handbook of International Relations* (2008). He also edits the Cambridge Studies in International Relations book series with Nicholas J. Wheeler.

RICHARD SAULL is Senior Lecturer in International Politics at the School of Politics and International Relations, Queen Mary, University of London. His doctorate was supervised by Fred Halliday. He has written and published on international revolution, US foreign relations and the Cold War including: *Cold War and after* (2007) and *Rethinking theory and history in the Cold War* (2001), and is co-editor (with Alejandro Colás) of *The war on terror and the American 'empire' after the Cold War*. He is currently working on a monograph on the international historical sociology of far right political movements.

BENNO TESCHKE completed his doctorate in the Department of International Relations at the London School of Economics and Political Science and is currently a Senior Lecturer in the Department of International Relations at the University of Sussex and a Visiting Research Fellow at the European Research Council-funded 'Research Project Europe 1815–1914' at the University of Helsinki. He is
