

A Marketplace of Ideas F. CLIFTON WHITE RESOURCE CENTER

In the marketplace of ideas, liberal democracy stirs a lot of interest. Some people would promote it, others would adapt it, some would analyze it, some would refute it, and some, with no agenda other than the vague sense that liberal democracy may improve their lives, would simply learn about it. All these people, whether specialists or not, approach

liberal democracy with varied and numberless questions. It was to address such information needs that Richard M. Scammon and F. Clifton White personally began collecting and

organizing authoritative materials on democracy in general and elections in particular.

When IFES was established in 1987, Scammon and White generously donated important portions of their personal collections to the budding resource center. As IFES expanded, so did the collection. Guiding the growth of the center was a clear mandate: "to collect and disseminate information and materials related to the administration of and effective citizen participation in democratic elections." So, besides the usual complement of books, reports and periodicals, the collection actively sought posters, ballots, fliers, handbills and sundry other materials generated by the electoral process in the field.

During the ensuing 15 years, the library at the F. Clifton White Resource Center has assembled highly specialized collections and, along the way, earned a reputation as a world-class center for democracy research. Special collections in the F. Clifton White Resource Center include:

- Ballots from numerous countries and elections, including absentee ballots, low-literacy ballots, referendum ballots and so forth.
- International constitutions and electoral codes, both current and historical.
- Hundreds of voter education posters, handbills, booklets and audio and video clips from around the world.

Election assessments and country reports published by IFES since 1989 comprise another special collection. These IFES

publications, joined by an astonishing range of country and topic reports prepared by selected non-governmental organizations, think tanks, academic institutions and individual scholars, form the informational heart of the collection. This unique literature provides researchers with vital insights on nearly every aspect of the workings and theories of international electoral systems.

To broaden access to its collection, the Resource Center makes extensive use of information technologies. It recently became a contributing member of Columbia

International Affairs Online (CIAO), a

database managed by Columbia University that provides a platform for academic researchers from more than 60 institutions to post the most current working papers, research projects, conference proceedings and journal articles. The library is committed to the proposition that pluralist societies thrive on open access to knowledge and invites questions and requests for research assistance from scholars, students, practitioners in the field and anyone interested in the advancement of democracy.

THE MANATT DEMOCRACY STUDIES FELLOWSHIP

Each summer, two outstanding graduate students from universities in the American Midwest come to Washington, DC for a summer of research under the Manatt Democracy Studies Fellowship Program. Founded in 1998 by Charles Manatt, former Chairman of IFES' Board of Directors, and his wife Kathleen, the program provides fellows with a stipend to spend six to eight weeks at the F. Clifton White Resource Center conducting research on election administration and civic participation in the political process.
