



These two handbooks, highlighting two important issues in any election, were prepared for use in the June 1999 South African general elections. Aimed at presiding and counting officers, A Handbook on Conflict Management informs them about processes, systems, and mechanisms available to manage conflicts that might arise at different stages of the electoral process. Case studies illustrate the skills required to manage conflict situations. A Handbook on the Media and Electoral Law, intended to increase the effectiveness of reporting, contains guidelines for media coverage, as well as summaries and extracts from electoral laws and regulations.

The Central Election Commission of the Dominican Republic created this voter education poster giving step-by-step instructions on how to vote. The process of voting in the Dominican Republic consists of two stages since registration is required on polling day. Voters are also separated by gender: women register to vote from 6:00-8:30 a.m. and cast their ballots from 8:30 a.m.-1:00 p.m.; men register from 1:00-3:30 p.m. and vote from 3:30-6:00 p.m.



Nadeau, Christian (Editor). Parliamentary and Presidential Elections in Russia 1999–2000: Technical Assessment with Recommendations for Legal and Procedural Reform.

Aimed at election administrators, lawmakers, and others interested in evaluating elections in Russia and pursuing legal and procedural reform, this comprehensive report describes the legal basis for the elections, procedures for conducting Duma and presidential elections, election monitoring and transparency issues, media and campaigning, campaign finance, automated election system, voting process and election results reporting, overseas voting, and adjudication of grievances. Each chapter includes recommendations for reform.

Ballot from Mexico: July 2, 2000 Presidential Election.

The names of the candidates appear with their party names and symbols on this ballot. The candidates are listed according to their party's registration date. The PRI (Institutional Revolutionary Party – Partido Revolucionario Institucional) is the oldest political party in Mexico, but the party was not registered under its present name until 1946. Founded in 1939, the PAN (Alliance for Change – Partido Accion Nacional) candidate, Vincente Fox, appears first on this ballot. A column for write-in votes is also included.



Formally established in 1993, the *F. Clifton White Resource Center* is a clearinghouse for information and materials related to the administration of and effective citizen participation in democratic elections. Its rapidly growing collection serves election officials and non-partisan civic groups around the globe, United States government offices, foreign embassies in Washington, and the growing academic community interested in electoral studies. *Elections Today* highlights some of the material recently obtained for the Resource Center.

Moldovan election results are available on IFES-Moldova's website. The site provides details about the most recent local referendum and the 2000 mayoral elections. The website includes Russian and Romanian versions of the IFES Moldova publication Vocea Civica, links to local events and the Moldovan constitution and electoral law. A particularly useful feature is the FAQs section, providing information on the election process.

This compilation of papers from the Regional Election Management Training Program for Commonwealth African Countries (held in Harare, Zimbabwe, November 2–13, 1998) deals with and makes recommendations on election law, electoral process, election management, voter education, voter registration, political party funding and campaigning, media, technology, election budgets, election observation, and election integrity. The book also provides a good example of how to preserve and publicize the dialogue between election managers, administrators, and other officials.

Republica Del Paraguay Justicia Electoral. Manual Para La Policia Nacional: Elecciones Agosto 2000 (Manual for the National Police: August 2000 Elections)

Paraguay's Center for Information, Documentation, and Education prepared this manual for the vice-presidential elections of August 13, 2000. Intended to train the National Police to maintain law and order during the elections, it contains summaries of relevant articles in the electoral code and the penal code pertaining to elections, electoral conflict, and procedures on how to handle them. Lists detail items and behaviors prohibited in the polling place (e.g., carrying guns or consuming alcohol) and actions that constitute fraud (e.g., coercion of voters or falsification of documents).
